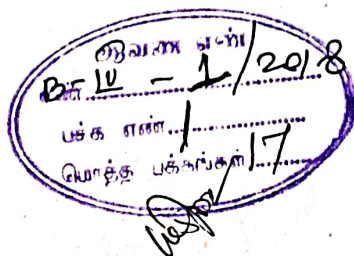

DEED OF TRUST

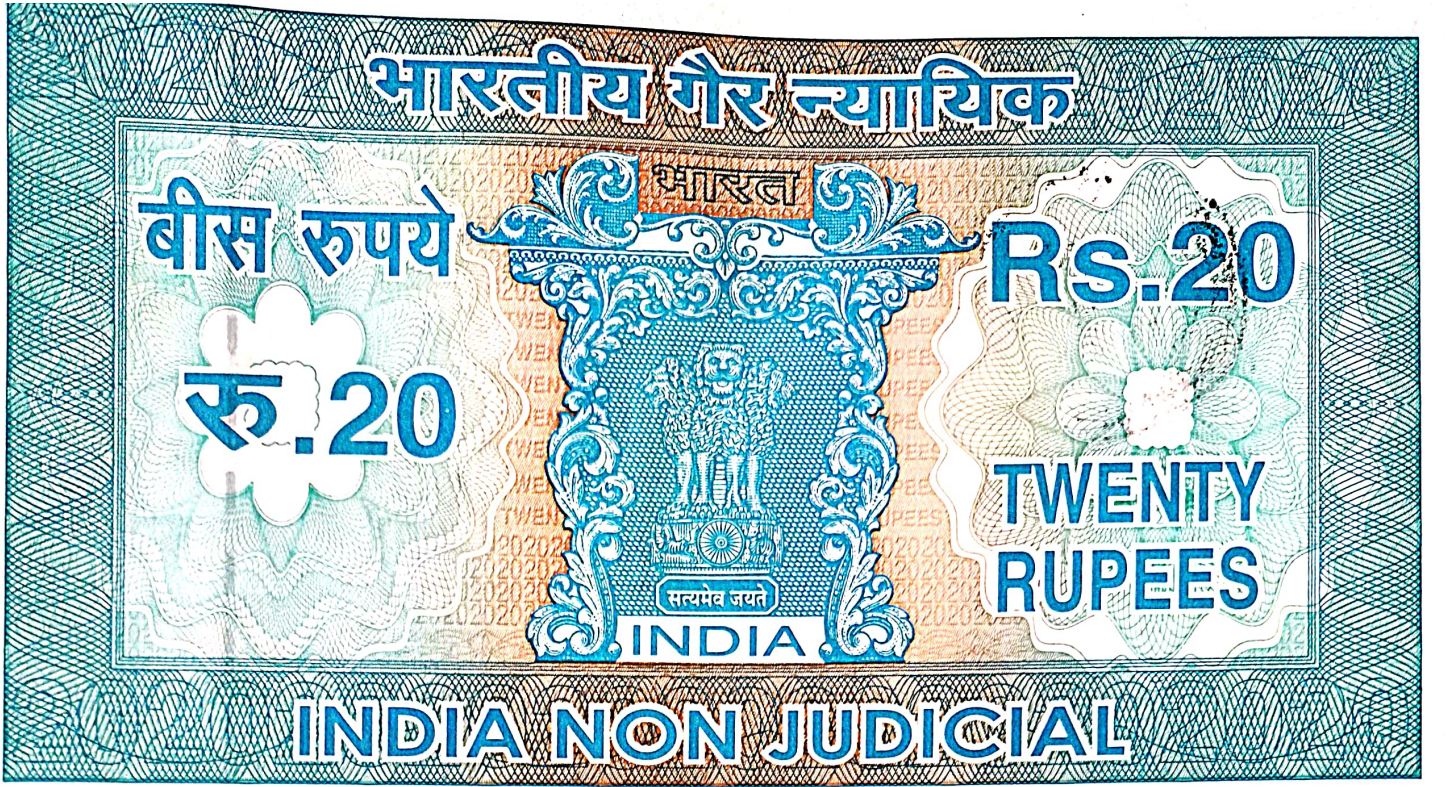

ii) To start, maintain and run Hospitals, Nursing Homes, Clinical Lab, Home for the aged people without any profit motive.

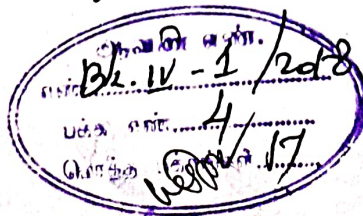
iii) To bear the Medical and Educational Expenses of Poor People.

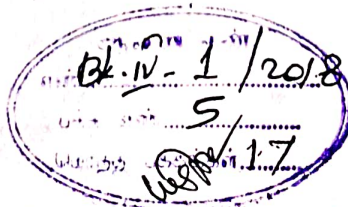

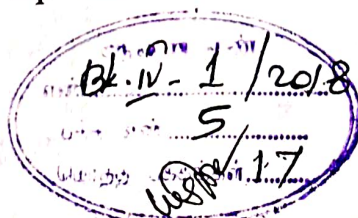

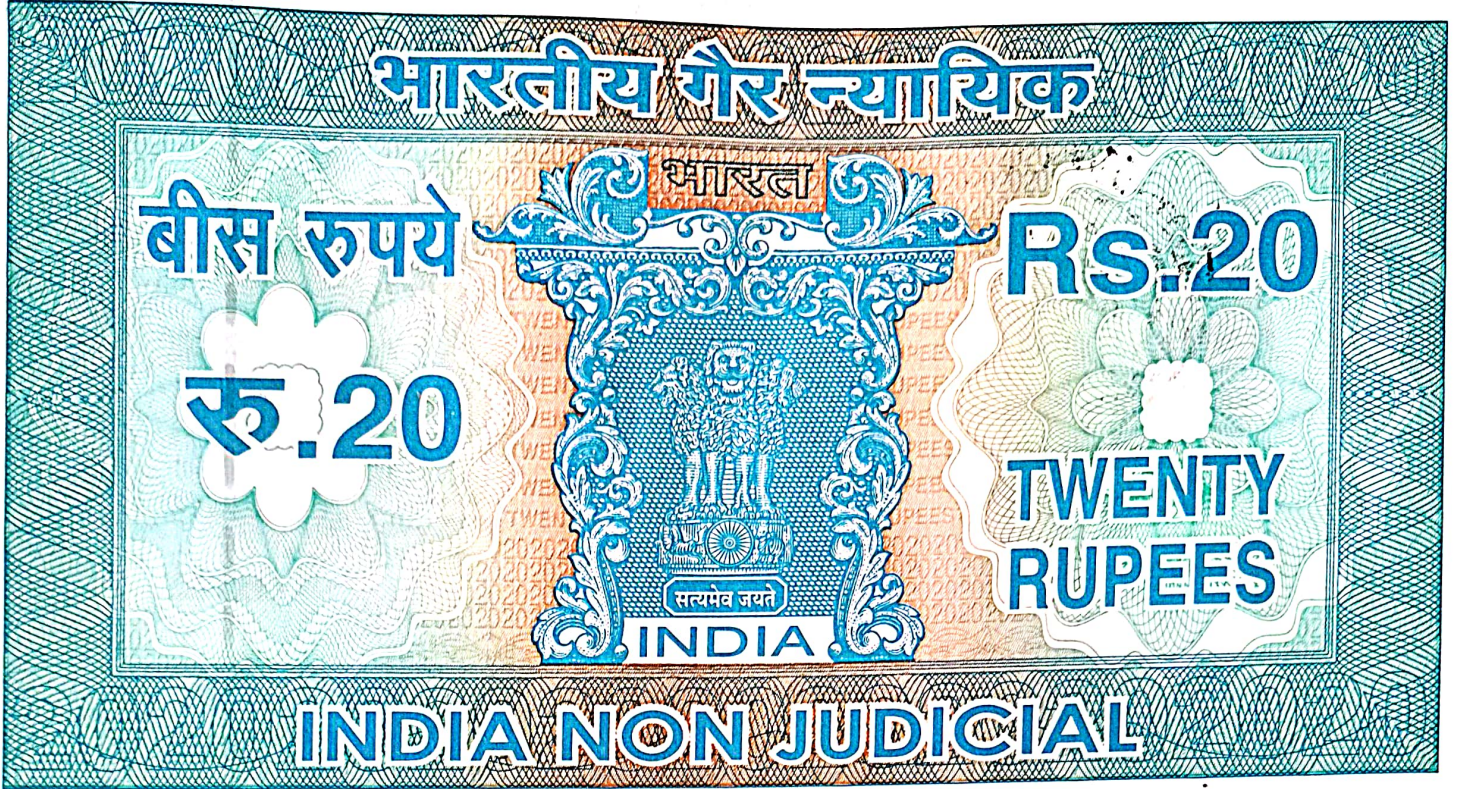

v) The Trustee shall at all time stand indemnified in respect of any act that they may have bonafide done, suffered or ornitted to be done in respect of matters relating to the Trust.

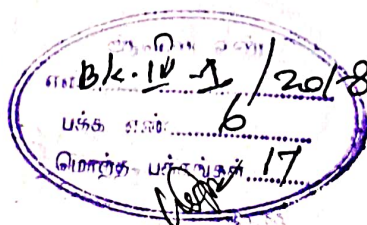
8. The Board of Trustees shall have the following powers:

iii) To cancel or revoke any appointment of any employee or attorney.

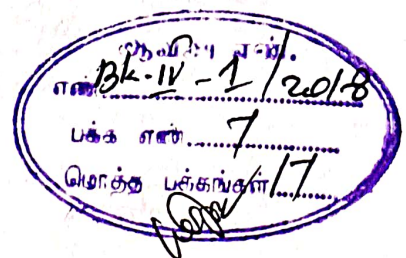

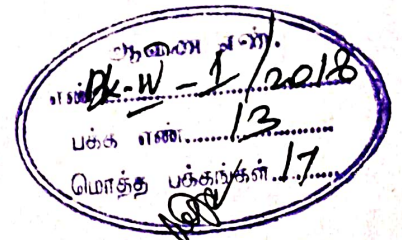

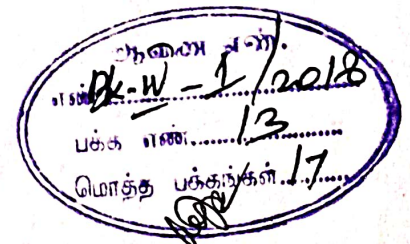
